EDITORIAL NOTE

This code has been prepared pursuant to authorization by the Kenyon city council under the authority of Minnesota Statutes, sections 415.02, 415.021, and 599.13. It may be referred to and cited as "The Kenyon City Code of 1999", or "The Kenyon City Code". The code is a revision, rearrangement, re-codification and re-enactment of all existing ordinances of the city, except for certain ordinances of special application.

The code has been arranged under functional headings and organized under a decimal numbering system for chapters, sections, subsections and subdivisions. The new code contains a system for the integration of new ordinance in a way that will provide continuous updating of its provisions. A table of contents designed for quick, accurate access to the code is included.

Revisions of a minor nature to remove obsolete provisions have been made and some new provisions not previously enacted have been added. Ordinances formerly of record but not included herein which have not been specifically repealed are still in effect and in full accord with the code.

General provisions applicable to all sections of the code have been collected in Chapter I, and whenever possible and desirable, provisions of state law and state rules and regulations have been adopted by reference. These techniques avoid unnecessary duplication of material and make the code a more useable document.

The annual license and permit fees resolution, certain administrative resolutions, and ordinances of a transitory nature or of limited application are not included but are contained in separate appendices to the code.

ORDINANCE NO. _____

AN ORDINANCE RELATING TO CITY GOVERNMENT
ADOPTING THE KENYON CITY CODE OF 1999

THE CITY COUNCIL OF THE CITY OF KENYON ORDAINS:

Sec. 1. Minnesota Statutes, sections 415.02, 415.021 and 599.13 (Act) authorize the city to codify its ordinances and print them in book or loose-leaf form. The council has directed the city staff and city attorney to codify the city's existing ordinances. The act also provides that any ordinance included in a new city code but not previously published is sufficiently published if a substantial quantity of the code is printed for distribution to the general public.

Sec. 2. The city council has reviewed a proposed recodification of the city's ordinances in a recodification entitled The Kenyon City Code of 1999 (Recodification). The recodification is on file with the city clerk.

Sec. 3. The recodification is adopted.

Sec. 4. The city administrator is authorized and directed to prepare sufficient copies of the recodification for use by the city council and the city staff and for general distribution to the public in accordance with city policies regarding the distribution and availability of city documents.

Sec. 5. This ordinance and the recodification are effective on March 3, 1999. Nothing in the recodification is to be construed to modify, abrogate or abridge (i) the rights, duties, liabilities, privileges or immunities of the city, (ii) the qualifications or terms of office of city officers as they existed on March 2, 1999 or (iii) any special ordinance or franchise not embodied in the Kenyon City Code of 1999.
